### Conference Committee Report Section-by-Section Analysis

#### **HOUSE VERSION**

SECTION 1. Section 64.012(b), Election Code, is amended to read as follows:

(b) An offense under this section is a <u>felony of the second</u> degree unless the person is convicted of an attempt, *in which* event it is a state jail felony [Class A misdemeanor].

SECTION 2. Transition provision.

SECTION 3. This Act takes effect September 1, 2023.

#### SENATE VERSION (CS)

SECTION 1. Sections 64.012(a) and (b), Election Code, are amended to read as follows:

- (a) A person commits an offense if the person knowingly or intentionally:
- (1) votes or attempts to vote in an election in which the person knows of a particular circumstance that makes the person [is] not eligible to vote;
- (2) votes or attempts to vote more than once in an election;
- (3) votes or attempts to vote a ballot belonging to another person, or by impersonating another person;
- (4) marks or attempts to mark any portion of another person's ballot without the consent of that person, or without specific direction from that person how to mark the ballot; or
- (5) votes or attempts to vote in an election in this state after voting in another state in an election in which a federal office appears on the ballot and the election day for both states is the same day.
- (b) An offense under this section is a <u>felony of the second</u> degree unless the person is convicted of an attempt. *In that* case, the offense is a state jail felony [Class A misdemeanor].

SECTION 2. Same as House version.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2023.

IN RE: HB1243 by Hefner (relating to the penalty for the offense of illegal voting; increasing a criminal penalty.), Conference Committee Report

### No significant fiscal implication to the State is anticipated.

The bill would increase the criminal penalty for illegal voting from a Class A misdemeanor to either a state jail felony for attempted illegal voting or second degree felony for illegal voting. It is assumed that any fiscal impact and any impact on state correctional populations or on the demand for state correctional resources would not be significant.

#### **Local Government Impact**

It is assumed that any fiscal impact to units of local government associated with enforcement, prosecution, supervision, or confinement would not be significant.

# **Certification of Compliance with** Rule 13, Section 6(b), House Rules of Procedure
